Breeding Agreement Colorite Cougar Boy PHAA 9953

This agreement made on: / /2011 by and between Nicole and Gary Steinberger, (stallion owner) and: (mare owner).

Stud Fee (\$800.00) Eight hundred dollars (*excludes agistment, feed, vet fees*).

Booking date / / 2011. Deposit amount \$200.00 deductible from stud fee, not refundable or transferable.

Balance of service \$600.00 to be paid in full prior to pickup of mare, whether mare has been pregnancy tested or not. A pregnancy test will be arranged no later than 45 days.

If all payments (service fee, agistment, feed, vet etc) are not made on pickup of mare, stallion owner has a lien over said mare until all fees are paid. Stallion owner will hold said mare on lien for the period of two months from arranged pick up date, (which is to be no later than 45 days after booking date), thereafter if debts are still outstanding will have the power of sale to recover money lost.

Please Read Carefully

(i) **Feed and Agistment.**

In addition to the stud fee, mare owner agrees to pay \$10.00 per day for dry mares (maximum of \$50 a week) and \$12.00 per day for wet mares (to a maximum of \$60 a week). This includes the provisions of feed.

(ii) **Veterinary Expenses**

Any Veterinary expenses incurred, including ultrasound pregnancy testing, farrier and worming needs etc... are to be at the mare owners' expense. The stud reserves the right to authorise any veterinary attention deemed necessary to any mare and or foal at foot residing at the stud for breeding services. All attempts will be made to contact the owners first but failing this, the stud has the right to act on behalf of the owners and will be notify the owners when the stud has reasonable time to do so.

(iii) **Mare Acceptance**

The stud exercises the right to refuse any mare for breeding if she fails to meet acceptable quality/or health standards. The Stud will take NO RISKS with mares that are a danger to handle. All mares are required to have shoes removed prior to arriving at the stud.

The mare owner takes full responsibility for the mare while she is being kept on Painted Dreams Property. In the event of any accident or injury to the said mare or caused by the said mare the mare owner takes full responsibility.

(iv) **Live Foal Guarantee.**

(‘Live Foal’ meaning able to stand and nurse for at least forty-eight (48) hours after birth)

In the event that the said mare does not deliver a live foal, the stallion owner agrees to give the mare owner the right to additional service to said mare at any time within one year from the last date of breeding said mare under this agreement. Stallion owner shall have no further liability hereunder for servicing said mare. A substitute mare may be used if said mare is found infertile or dies before she settles.

In the event that the said mare does not take and become in foal, the stallion owner agrees to breed that same mare again for no additional stud fee consideration at any time during the same or next breeding season at mare owners request. Mare must have been veterinary checked.
